Dear Parent/Guardian,

Plainedge High School is offering our students a limited number of openings in our Fall Driver Education program. Private and parochial school students who reside in the Plainedge School District are welcome. Students must be 16 years of age and have a valid NYS drivers permit to participate. Students may drop off registration forms beginning August 14 through August 17 in the main office. Parents need not be present to drop off registration form. Forms must be signed by **both** the parent and student.

Cost: \$430.00 per student

Location: Plainedge High School

Duration:

- First **driving** class begins on **Monday, September 11**
- First **lecture** class begins on **Tuesday, September 12**
- Last class ends on or about **Friday, January 26**

Course Structure:

- Students will be assigned to **one** of two 90 minute driving sessions at 2:05pm or 3:30pm.
- Students will also be assigned to **one** of three lecture classes held on Tuesdays from 4:15pm - 5:45pm **or** 5:45pm - 7:15pm **or** on Thursdays from 2:05pm - 3:35pm.

Attendance:

- Students must plan to attend all scheduled classes. **There are no exceptions.**
- Driving and lecture classes will follow the school calendar.
- Failure to comply with the attendance requirements will result in a withdrawal from the program.
- Inappropriate behavior will not be tolerated and may result in a withdrawal from the program.

Registration:

The registration form must be completed and signed by both parent and student.

- Students must have a valid NYS permit in order to register.
- The completed registration form, along with a check made out to **Plainedge Public Schools**, and a copy of the NYS permit must be submitted to the front office no later than August 17.
- **The student is responsible for picking up their schedule from Mrs. Ferguson in the Main Office before classes begin.**

4. I understand that to practice my driving skills without my instructor, I **must** have a Learner's Permit (MV-100), and I can only practice with my **parent/guardian** between the hours of 5:00 am and 9:00 pm.
5. I understand that Operator's privileges are obtained at age 17 with successful completion of the 48 hour Driver Education Course and the DMV road test.
