Dear Parent/Guardian,

Plainedge High School is offering our students a limited number of openings in our Fall Driver Education program. Private and parochial school students who reside in the Plainedge School District are welcome. Students must be 16 years of age and have a valid NYS drivers permit to participate. Students may drop off registration forms beginning August 13 through August 16 in the main office. Paperwork received after deadline date may not receive enrollment into program. Parents need not be present to drop off registration form. All forms must be signed by **both** the parent and student.

Cost: \$430.00 per student

Location: Plainedge High School

Duration:

- First **driving** class begins on **Monday, September 17**
- First **lecture** class begins on **Tuesday, September 18**
- Last class ends on or about **Monday, February 4**

Course Structure:

- Students will be assigned to **one** of two 90 minute driving sessions at 2:05pm or 3:30pm.
- Students will also be assigned to **one** of three lecture classes held on Tuesdays from 4:15pm -5:45pm or 5:45pm - 7:15pm **or** on Thursdays from 2:05pm - 3:35pm.
- **Requests for changes in driving/lecture times after registration process are not possible.**

Attendance:

- Students must plan to attend all 16 scheduled classes. **There are no exceptions.**
- Students are allowed only **three absences and must be made up during the semester.**
- Driving and lecture classes will follow the school calendar.
- Failure to comply with the attendance requirements will result in a withdrawal from the program.
- Inappropriate behavior will not be tolerated and may result in a withdrawal from the program.

Registration:

The registration form must be completed and signed by both parent and student.

- Students must have a valid NYS permit in order to register.
- The completed registration form, along with a check made out to **Plainedge Public Schools**, and a copy of the NYS permit must be submitted to the front office no later than August 16.
- **The student is responsible for picking up their schedule from Ms. Knight in the Main Office by Friday, September 7th.**

4. I understand that to practice my driving skills without my instructor, I **must** have a Learner's Permit (MV-100), and I can only practice with my **parent/guardian** between the hours of 5:00 am and 9:00 pm.
5. I understand that Operator's privileges are obtained at age 17 with successful completion of the 48 hour Driver Education Course and the DMV road test.
